Divorce Corp Testimonial Suggested Guidelines

We want to hear your story in your own words. Try to stay relaxed and speak as if you were talking to a close friend during the interview. We will ask you to describe some of the details of your story. As you respond, try to summarize what the case is about in as few words as possible. Try to avoid using dates and people's names (use "ex" instead of *Jim*, "daughter" instead of *Cindy*, etc.). Try not to get bogged down in details or legal jargon (say, "he told the judge that I was not a good parent" rather than saying "he filed an ex-parte motion and came in, pro se in Judge Jones' courtroom, and claimed that the guardian ad litem thought I was narcissistic".)

Set Up for Testimonial

To ensure that you can be clearly seen and heard as you tell your story, please follow these guidelines for the video set up.

- Find a quiet space with no distractions in the background.
- Make sure you are not back lit – you need to have light on your face. Light in front of you is good. Behind or to your side is not.
- The background should be bright and orderly.
- Dress in solid colors, professional casual attire that you are comfortable wearing.
- Set up the camera so you are visible from your chest up during the interview.
- Look directly in to the camera and speak to it as if it were a friend or family member that you're comfortable engaging in a conversation.
- Turn off all external sounds/notifications on your phone (an incoming email/text/call for instance) that could impede recording.
